



WHAT IS VALENOVITA?

VALENOVITA is a combination of Food and Plant items prepared in powder form.

■ WHO IS MANUFACTURING VALENOVITA AND WHAT REPUTATION OF COMPANY?

Award Nutraceuticals LLP is a company situated at Porur, Chennai. It presently manufactures 11 health supplements under the brand name HOLIN, which are widely used by general public and specific needy people.

■ WHO HAS FORMULATED VALENOVITA?

VALENOVITA, a combination of Millets, Lentils and Ayurveda medicinal plants is formulated by highly educated and experienced Diet specialist, Pharmacist and an Ayurveda Medical Practitioner.

■ WHAT IS VALENOVITA USED FOR?

It used as food supplement in general public and as food for women desiring child birth and it used during pregnancy for mother and child health, and facilitates normal delivery. It also helps in increasing mother milk production. Since this supplement also helps in male infertility, this may be used by gentlemen who seek progeny.

HOW IS VALENOVITA PRODUCED?

Millets, Lentils, Cereals are mixed as per the formula and to this powder Ayurveda Medicinal plants having fertility actions are added.

HOW DOES VALENOVITA DIFFER FROM OTHER FOOD SUPPLEMENTS AVAILABLE IN MARKET?

First of all, similar combination of Valenovita is not available as a dietary supplement in the open market. Further, in open market most of the food supplements are prepared as powder directly from raw materials grown in chemical environment.

Whereas in our preparation Millets, grown in organic farming, are procured and soaked and cleaned. Lentils and cereals, grown under organic farming are procured and soaked in water filled in mud/clay pots, and then they are sprouted in mud pots. These processes are done for natural components act better in humans

■ WHAT ARE THE INGREDIENTS INCLUDED IN VALENOVITA?

Important ingredients include Millets: Green gram, Horse gram, Fenugreek, Little millet, Foxtail millet, Kodo millet, Barnyard millet, Browntop millet, Flaxseed, Sesame seed, Soya bean, Barley, Beetroot, Carrot, Dry Ginger, Ellachi, Garlic, Goji Berries, Pumpkin seed, Cucumber seed, Sweet potato & Brown sugar.

Ayurveda Medicinal Plants: Aloevera, Ashoka, Amla, Castor root, Devadar, Gokshur, Harde whole, Lodhra, Pomagranate, Indian sarsaparilla, Sappanwood, Punarnava, Sandalwood, Shatavari, Behada, Tailed pepper & Yastimadhu.

■ UNDER WHAT CONDITIONS CAN A PERSON CONSUME VALENOVITA?

Primarily this is used as Health supplement to all people irrespective of sex or age, who are deprived of normal food intake due to any reason medically or non-medically. Persons having malnutrition, low blood content say anaemia, calcium, iron, vitamins deficiency may consume this food supplement. This product provides good protein in people suffering from protein deficiency.

Many of the ingredients of this health supplement contain naturally occurring vitamins and consuming this prevents vitamin deficiency particularly Vita A, B, C and D. Further they contain good Vita E and provide anti-oxidant effect. It is also very useful in patients suffering from infertility and scanty lactation in women.





HOW DOES VALENOVITA HELP INFERTILITY PATIENT?

Infertility patients may not get good environment for conception due to anaemia, imbalance of sexual hormones viz. Testosterone, Oestrogen, progesterone etc, improper formation of ovum, and uterus unable to withheld foetus. Botanicals from Ayurveda, Aloevera, Shatavari, Behada, Amla, Cucumber seed, Gokshur, Lodhra, maintain normal sexual hormones in both sexes and normalises menstruation in women. Punarnava, Devadar, Sarasaparilla, Castor root, Sappanwood, Sandalwood, Pomegranate, Yastimadhu, Ashoka, Tailed pepper will take care of normalcy of ovum production and keep uterus healthy. The combination of all these effects on Infertility patients will recover and maintain healthy life. Sarasaparilla has good effect on milk production in mothers.

Therefore, consuming the Valenovita may help in infertility patients either as a food supplement or additional fertility action

■ WHAT QUANTITY TO BE TAKEN?

As a food supplement for normal person 40gm per day or 20 gm two times a day, and as a complete food 80 gm per serving, two times a day

HOW MUCH VALENOVITA BE CONSUMED?

This powder shall be taken along with milk, buttermilk, or warm water.
